**9. Consideration to approve the approval of an alcoholic-beverage license for Willie Macs**

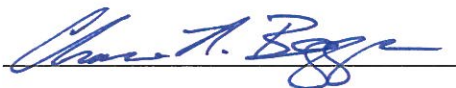

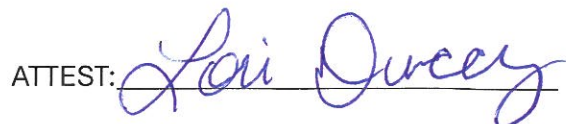
