There is an annual review by the Board of Commissioners. Salary - \$130,000. Vacation and Sick – per our HR policy. Health care and benefits – per our HR policy. The option to choose between a vehicle allowance of \$525 or using a county vehicle. This decision will be made between Headley, the county attorney, Mr. Burton, and Chairman Beggs. Commissioner Hollimon asked with the October 1, 2025, hire date, would it overlap with Mr. Headley's time at the county? ICM Headley responded that this will be a transitional period, and how this is handled is up to the Board of Commissioners. As of now, Headley's last day will be October 8, 2025. Chairman Beggs asked are there any questions about the appointment.
