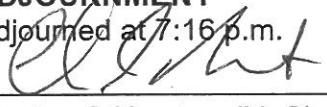
EXECUTIVE SESSION - Property

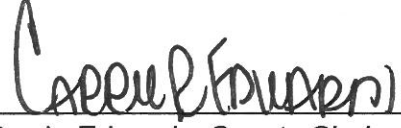
