11. **Consideration to Approve the 2025 Budget Schedule.**

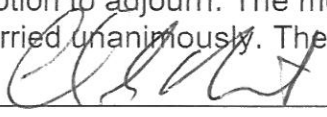

12. Consideration to Approve May 2024 ACO Report.

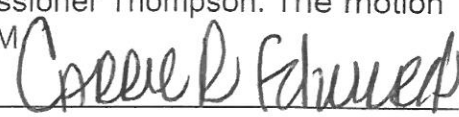
